



The *Asian Journal on Mediation* (“Asian JM”) aims to advance the practice and development of mediation and mediation techniques in Asia. Its goal is to be a forum for practitioners of mediation in Asia to share their ideas, practices and techniques in mediation. Through the exchange of diverse experiences and ideas, and the exploration of the different contexts in which mediation takes place, it is hoped that mediation practitioners in Asia will be influenced to further develop their skills and techniques. With the exploration of models and applications of mediation across Asia, it is hoped that there will be an increased understanding of mediation and the promise that it holds.

The Asian JM is published by the Singapore Mediation Centre (“SMC”) which determines its editorial policy in consultation with its General Editors, Professor Joel Lee, Professor Lawrence Boo and Associate Professor Dorcas Quek Anderson. It is a peer reviewed journal and its content is governed by its General Editors.

Editorial Policy Guidelines

All references to the Asian JM shall mean the “Asian Journal on Mediation”.

A. CONDITIONS FOR PUBLICATION

1. **Originality** All papers, articles, case notes and book reviews (hereinafter “Contributions”) submitted to the Asian JM must be original. As a condition for publication, the Author(s) warrant(s) to the Asian JM and its Editors and publishers that the Contribution does not infringe the copyright or any other rights of any third parties.
2. **Exclusive Submission** By sending a Contribution to the Asian JM, the Author(s) warrant(s) that the Contribution is not being simultaneously considered by any other publication, and that the Contribution shall not be sent to another publication until a response is received from the Editors of the Asian JM.
3. **Individual Submission** Contributions should be submitted on an individual basis, as opposed to a firm or organisation collective effort.
4. **Peer Review** The Editors reserve the right to send a Contribution to an independent referee for evaluation; the identities of both Author(s) and referee(s) will remain confidential at all times.
5. **Offensive, Defamatory or Other Material** As a condition for publication, the Author(s) warrant(s) that the Contribution does not contain any obscene, offensive, defamatory or racially prejudiced material and that the Contribution will not expose the Asian JM, its Editors or publishers to any civil or criminal proceedings. The Author(s) agrees to indemnify the Asian JM, its Editors and publishers for any liability whatsoever that may be incurred as a result of the publication of the Contribution.
6. **Copyright** The Author(s) hereby assigns to SMC, and SMC hereby accepts, for the full period of copyright throughout the world and all renewals and extensions thereof the full copyright in the Contribution. This assignment includes, but by no way of limitation, the sole and exclusive right to publish, sell, give access to and license the use of the Contribution in all languages, in whole or in part, including any abridgement and substantial part thereof, in book form, in a database with other works and in any form, including, without limitation, mechanical, electronic and visual reproduction and publication, electronic storage and retrieval systems, including delivery of or giving access to the Contribution by Internet, extranet and intranet and all other forms of electronic publication not known or hereinafter invented.

B. SUBMISSION GUIDELINES

1. Contributions should be submitted in electronic form in Microsoft Word format by e-mail to smc_enquiries@sal.org.sg.
2. Submission to the Editors does not constitute acceptance for publication; the Author(s) will receive a notification of acceptance or rejection from the Editors.
3. As a general guide, articles should have a minimum of 5,000 words; shorter notes, including comments on recent cases and legislation, a minimum of 1,000 words; and book reviews, a minimum of 800 words. Departures from this guideline will be considered on a case-by-case basis by the Editors.
4. Submissions should state the full names of the Author(s) (with the family name underlined or in bold); mailing address; e-mail address; and telephone and fax numbers, if any.
5. Contributions must be in English.
